Duties and responsibilities

Key duties

To provide routine husbandry to the animals within the BSU.

To ensure adequate provision of food and water as described in Standard Operating Procedures (SOPs).

Daily checking of cages and animals for signs of husbandry and welfare requirements.
Reporting observations to supervisor.

Cleaning out of animals as directed and to facility routines.

Maintain all working areas to the acceptable standard by general cleaning as per SOP.

Provide out of hours, weekend and public holiday cover on a rota basis for which overtime will be paid.

Participate in facility cleaning, cage-washing and preparation of cages.

Collect and deliver equipment, consumables, and waste within the BSU and across ICR sites, following local rules.

Prepare water, cages and equipment with bedding and enrichment; package and sterilise as required.

Record levels of achievement and expertise in personal training records.

Any other duties that are consistent with the nature and grade of the post that may be required.

General

All staff must ensure that they familiarise themselves with and adhere to any ICR policies that are relevant to their work and that all personal and sensitive personal data is treated with the utmost confidentiality and in line with the General Data Protection Regulations.
